### **RULE CHANGE SUBMISSIONS NOW DUE**

Motorcycling Australia (MA) would like to advise that rule change submissions for the 2018 Manual of Motorcycle Sport (MoMS) must be received by Friday 03 March.

The Manual contains the General Competition Rules, which govern the participation and conduct of Motorcycle Sport in Australia. Changes are sometimes made to these rules to make competition easier or fairer, to reflect changes in technology or equipment, or to make the meaning of the rules clearer.

Clubs, State Controlling Bodies and MA Members are welcome to submit suggestions

for amendments to existing rules, and suggestions for the addition of new rules, to help make the sport better for our competitors.

Submissions must be completed on the official Rule Change Form and returned to Nicole Van der Sant via email at [rules@ma.org.au](mailto:rules@ma.org.au) no later than the 3rd of March 2017 to be considered. Submissions will be forwarded to the relevant Commission & Committees for consideration.

## **HCMC President Bob Humphrey's clarifications and corrections in regards to Bill Hargraves speech to HCMC AGM attendees 21/12/16.**

### ***The Committee runs the Club issue.***

Bill implied that the club was not being not managed in accordance with the Act. The new Act and Constitution has only just been brought in and the club has been run in accordance with the Constitution we have in front of us at any given time.

If a member brings to the attention of the committee any issue about this the committee would of course act appropriately once made aware of any potential problem. If we are unaware of them then we cannot correct problems.

### ***HCMC runs 3 way race meetings issue***

Would we then assume that a HCMC member riding in a Victorian or SA Championships has no rights to a result on Bill's reasoning?

### ***Perpetual Trophies should only be awarded to HCMC member's issue***

(2016 trophy was awarded to a modern rider)

The 2015 perpetual trophy for most improved rider went to a non-Historic rider under Bill's presidency, so a precedent had already been set and thus a basis for following committee's to base decisions on. If members want this changed then it is simply a matter of moving a motion at any monthly club meeting and voting on it.

### ***New Merchandise Logo issue.***

A subcommittee organised the changed merchandise logo (a P3 Manx) with club members voting on the design, I was not involved and did not know of the design cost until the treasurer advised there was one. The VP confirms he was not "taking the piss" either.

### ***Round 1 Wanneroo. P2 / P3 race laps cut issue.***

Race meetings are run by the Steward and not by the Committee, their decisions are made with the best intentions.

### ***Round 2 Wanneroo. Duty of care in sidecar race crash issue.***

It was an unfortunate crash between 2 sidecars, but crashes have nothing to do with the Committee. Under Bills presidency all sidecars raced together too. Please note the 2016 Committee had offered Historic only sidecar race, but the members liked the mix. If members want this changed then it is simply a matter of moving a motion at any monthly club meeting.

### ***Collie Tuning Day issue.***

Fast Historic riders/bikes are asked not to be in slow group. I discuss these issues with available committee on ride days. This is a rider safety issue and is again part of the agenda for the 2017 committee. Our tuning days showcase Historic bikes to riders of modern bikes, and is our best source of riders finding a Historic bike and joining Historic racing.

### ***Membership form amendments issue.***

2016 Committee can see who rides what from entries forms at any time. Bill actually amended this form as president and I don't recall the committee or the membership being involved in these decisions. The 2014 membership form does not include the period of bike, apparently irrelevant back then in 2014, but now it is according to Bill?

### ***Rule 20 aligned to Pre Modern constitution breach issue***

If a premodern class or class not covered under the MOMs is a direct contravention of the Constitution as suggested, why didn't previous committees under Bills presidency ban Rule 20?

If this is a correct reading of the Constitution then we will have no choice but to remove these classes, or change the Constitution. Endorsed HCMC pre-modern rules with a 1997 cut off now align exactly with previous endorsed Rule 20 rules for 2017.

Most Historic clubs run their own classes, mainly for financial and encouragement reasons, Eg: class C and p3 650 sidecars, LC 250 cup.

We chose Rule 20 (now pre modern) as far back as 2005 - why? Because we as a club were going backwards. Rule 20 probably saved the club! When P6 came out, most of these bikes became log booked P6 bikes. We may expect the same growth of a P7 is introduced?

### ***PCRA NSW issue***

If Bill wants a copy of the PCRA of NSW constitution, he should join the club and the ACT will cover his concerns. I have no idea what this has to do with the HCMC.

### ***Incompatible bikes issue***

Bills statement "...races where a 750 push rod bike in with 1100cc twin overhead cams bikes are incompatible",...

I rode a pushrod BSA in these classes for years, and one of the overhead cam bikes I competed against was Bill's, so it did not seem to be an issue then so why bring it up now? The Committee always tries to group bikes in a compatible way within the constraints of organising a race meeting. If members want this changed then it is simply a matter of bringing it up for discussion at any monthly club meeting.

### ***Focus on objects/purpose of the HCMC issue.***

I believe the committee does this, when I studied Bill's reasons for nominating for President, I was personally insulted and hurt. The statement that riders have gone to him to say they are not happy and won't speak up publicly because they don't have anywhere else to ride, is a terrible statement to make. It infers that if they went to the committee with a complaint they would be penalised by having nowhere to race. I pride the committee and myself as very approachable people who go out to their way to fulfil the part of the

constitution 3 object (V11) to promote friendship and co-operation between members and affiliated clubs across Australia.

Bill says Co-operating with kindred bodies does not mean take on board whatever other clubs are doing. He seems to very interested in other State clubs as seen in his LC 250 spiel at the AGM, where he said that it was a great class, and that our club should consider it, but as we haven't got enough LC 250's, perhaps we could run a RGV 250 Cup as it's our most popular class? If members want these considered then it is simply a matter of bringing them up at any monthly club meeting.

***Unable to identify initiatives in 2016 that encourage Historic bikes to racing issue.***  
Here a few that in my opinion that promoted our Club to potential historic riders in 2016:

- New website developed
- Facebook page created
- Club promotional banners raised at Island Classic, same again for 2017.
- New Club banners for roads leading to Collie and Barbagallo promoting Historic racing
- Aligning November meeting with Collie round the houses event, biggest crowd ever?
- Dedicated AMCN article published
- Funds raised for HCMC Island Classic team
- Historic only sidecar race held. Historic sidecar race starts P3 sidecar ahead of field to ensure full laps reached, puts historic sidecar in front of the field.
- Club ran 8 meetings in 2016
- HCMC Rule 20 aligned by committee to be consistent with Pre Modern rules to enable members to prepare bikes, most likely to be period 7, in the future.

As always, any member who has some ideas about ways we can do things to encourage people to take up/rejoin historic motorcycle racing with our club then just let us know.

Many of the items listed above are things that should have been brought up at monthly meetings, the correct venue for discussion and resolution, not at an AGM.

While passionate debate is always welcomed and valuable as a guide to members wishes, they should always be done in a manner that is non-confrontational and with respect for all other club members/volunteers, this is also in our Constitution and must be adhered to by all members at all times.
